- The fee to write or re-write the exam is **\$115 tax included**; this does not include your Annual Certification fee. Certificates and licenses must be obtained through the Department of Environment. Fees are non-refundable and non-transferable.
- Payment must be made 4 days prior to the scheduled exam session. It is mandatory that upon arrival at the scheduled exam session you show a valid **PHOTO ID**.
- Exams can be written at any scheduled session. However, a minimum of eight (8) candidates is required per exam session. Private/group sessions may be arranged upon request. If you are writing two exams, you must write both in one exam session for certification.
