CANADA SAFETY COUNCIL CERTIFIED ATV SAFETY TRAINING

DATE & TIME:	Wednesday, May 22 nd , 2024 beginning at 8:00 AM
LOCATION:	In front of Strickland Building, 675 Strickland Lane, Maritime College of Forest Technology, Fredericton NB.
OBJECTIVES:	This program is designed to help participants
	\blacktriangleright To be familiar with the basic operations of an ATV.
	Learn how to perform a safety check and basic maintenance of ATVs before starting a trip.
	Learn basic driving skills, including balance on turns, hills (ascending and descending) travelling over different types of terrain, and traversing of slopes.
	 Learn emergency stopping and turning procedures.
CANDIDATES:	It is evident by today's size and type of ATVs that they are not a toy. ATVs are powerful and heavy enough to injure any rider. The Certified ATV Safety training, developed by the Canada Safety Council, provides the drills that enable you to keep all four wheels on the ground and learn how to avoid potential injuries. This course is for the person who is new to the sport as well as more experienced riders who would like the opportunity to receive certification in ATV safety. The dealer will familiarize yourself with your new ATV and cover its basic operations; however, they can't introduce you to the typical terrain you will encounter in your travels. The Certified ATV Safety Training will introduce you to a wide variety of terrain.

The best courses are based on the belief that most students learn by doing. We will ensure that you will get a lot of practice. The training will expose you to many situations that you will likely encounter in your travels – and you'll discover new skills you can use every day. The course will encourage you to "ride at your own level" during drills. We will also provide individual feedback to ensure improved riding performance. Even experienced riders learn new techniques too, techniques to improve safe riding.

FORMAT: Certified ATV Safety Training will be conducted in an informal manner. The workshop consists of a short introductory safety lecture followed by the majority of training spent learning and practicing safe ATV operation in a closed training area.

Please note the following: Make sure you dress for the weather as this course will run rain or shine. You'll need your own ATV in safe and good working order with the proper insurance and licensing. Personal protective equipment (PPE) is required as well. It includes a certified helmet, goggles, sturdy footwear, and leather or riding gloves. Bring your own lunch or snacks, and something to drink as you will be in the field all day.

- **INSTRUCTOR:** Jim Bowen is a retired instructor from the Maritime College of Forest Technology. Jim uses a down-to-earth approach in his delivery of training, encouraging students to feel comfortable to participate by asking questions. His teaching goal is to have you master the information and skills of safe ATV operation in this course and to attain Canada Safety Council Certification.
- **ENROLMENT:** Enrolment will be limited to eight candidates on a first come-first served basis. If the proposed course is full or there is insufficient enrolment to hold the session, you will be notified as to alternate dates. You are required to supply your own ATV in mechanically sound working condition and all PPE. MCFT can supply an ATV for an additional fee if you do not own your own.
- MINIMUM AGE: All participants must be 16 years of age or older. Proof of age may be required.

TUITION: Tuition for the program including supplies is \$250.00 + HST. It is recommended to use your own ATV but we give you the option to rent one from us at the rate of \$150 + HST.
